# **EXCELLENCE IN ADVOCACY**

Mike Ball has established himself as one of California's preeminent trial lawyers through his extensive experience trying cases across multiple jurisdictions. He has had civil jury trials in courtrooms throughout California, including Fresno, Clovis, Madera, Merced, Visalia, Hanford, Bakersfield, Los Angeles, and Modesto, as well as Las Vegas, Nevada. His practice encompasses medical malpractice, wrongful death, wrongful termination, breach of contract, industrial accidents, products liability, general negligence, insurance agent/broker liability, and premises liability cases.

### **OUTSTANDING VERDICTS**

Mr. Ball maintains an active and successful trial practice, handling complex medical malpractice defense cases, professional liability matters, and general civil litigation throughout California. His work has earned him selection to the "Top 100" list of the Northern California Super Lawyers 10 times and America's Top 100 Civil Defense Litigators® for 2018-2022, reflecting a sustained record of outstanding results for his clients. He was also recognized by Fresno Magazine as one of the "Top Attorneys as Chosen by Their Peers."

Mr. Ball has 40 civil jury trials in his 40 years of practice. He has successfully tried cases against other highly respected ABOTA members, including past ABOTA Trial Lawyer of the Year recipients Warren Paboojian and Jeffrey Raynes. All of the cases he has tried to a jury defending physicians on medical malpractice claims (19) have resulted in defense verdicts for his clients, many of which where there were seven figure demands.

In the one and only case he has tried on behalf of a plaintiff, he obtained a Judgment in 2012 in excess of \$5,000,000 in conservative Madera County (later reduced on appeal, hence discouraging further attempts on that side!).

In 2021, he obtained a directed verdict for his physician client in a significant exposure case that resulted in a verdict against the co-defendant for \$49,800,000 (\$17,000,000 judgment) in Fresno County Superior Court.

# **CONTRIBUTION TO ABOTA**

Since 2003, Mr. Ball has served ABOTA with distinction. His dedication to the organization is reflected in his service as President of the San Joaquin Valley Chapter (2010), and on the Board of Directors of CAL-ABOTA (2009-2011). He has shared his expertise through ABOTA's educational programs, serving as a featured speaker for two San Joaquin Valley Chapter Masters in Trial programs: a 2013 presentation on pre-trial litigation and a 2005 program covering trial techniques from opening statements through jury deliberations in a sexual harassment case. Mr. Ball remains an active member in ABOTA and through his board service and educational contributions, Mr. Ball has consistently advanced ABOTA's highest principles.
